ABSTRACT

KURNOOLO University Education - Degree Colleges - Establishment of Silver Jubilee Government College of Arts, Science and Commerce at Kurnool during 1972-73 - Orders - Issued.

ORDER:

Government have had under their active consideration for some time now the establishment of a Degree College open to talented students. In this regard they have been considerably encouraged and guided by the recommendation of the National Commission on Education (1964-66) that Colleges with substantial autonomy in matters, both academic and administrative, should be encouraged to come up so that they become models of academic excellence in Higher Education. With this object in view, the Government have decided to establish a Degree College for Men at Kurnool, to be named the Silver Jubilee Government College of Arts, Science and Commerce, taking advantage of the Twenty-fifth Anniversary of Indian Independence which falls during the academic year 1972-73. The purpose of the Government is to seek progressively an Autonomous status for this college subject to such terms and conditions as the Sri Venkateswara University, within whose territorial jurisdiction the College is located, may choose to prescribe. The College shall be a State institution with admissions open through an entrance test to non students from all over the State.

2. The College shall be located in the present buildings (with hostel attached) of the Government College of Education, Kurnool and shall be started immediately subject to the concurrence and affiliation by the Sri Venkateswara University, Tirupati. The buildings of the Government College of Education together with the hostel attached shall be taken over by this college for this purpose. Accordingly, Government direct that a Degree College for men be started at Kurnool from August, 1972.

3. The College shall be started initially with 150 students in the first year degree class selected by open competition through a written test and, if necessary, an interview, with suitable reservations for scheduled castes, scheduled tribes and backward classes.

4. Each student shall be paid a stipend of Rs.100/- P.M. for all the 12 months of the year in accordance with the rules to be prescribed for this purpose and residence in the college hostel shall be compulsory for all the students of the college.

5. The college shall be affiliated to the Sri Venkateswara University.

6. The staff, equipment and other physical requirements

shall be provided as far as possible by adjustment from within the existing staff and physical resources of the Department.

7. The college shall be a State Institution with provision for admission of students from all the three regions of the State i.e., Andhra, Ravanasooma, and Telangana.

8. The expenditure on the establishment of this college which is estimated at Rs. 2.00 lakhs will be met by reappropriation to the extent of Rs. 1,80,000/- from the provision of Rs. 1,97,400/- made under "28 Education - A. University (a) Government - Professional colleges - A. Teachers colleges for Men A-(1) Teachers Colleges for Men (Rest of the State) - 4. Contingencies - Stipend and award of scholarships to B.Ed., trainees" and also to the extent of Rs. 62,000/- from the provision made under "28 Education - D. Social - m. Government Special schools - A. Training Schools for teachers (Basic and Non-Basic) 4. contingencies - Scholarships and stipends" and be debited to 28. Education - A. University Schemes included in the Fourth Five Year plan - 7 - Opening of New Colleges for General Education".

9. This order issues with the concurrence of Finance (⁽²⁾) viz. their N.O. No. 2525/TSP/72, dated 7-8-1972.
